# From the AIA's desk ...

# Social Entrepreneurship & MSME-DI, Hyderabad Initiative

Over the last decade the concept of social entrepreneurship has come to assume more and more prominence. The content of the concept is, however, not new. The reason for its increasing popularity is that individuals get to do what they have been wanting to do all along. They go to extraordinary limits with their brilliant ideas and bring about a positive change in the society, against all odds.

Social entrepreneurship has been defined differently by different researchers. However, all of them agree invariably that social entrepreneurs are associated with non-profit sectors and organizations, but do not wave away the need for making profit: even social entrepreneurs need capital to carry on with the process and bring a positive change in the society.

Broadly described, social entrepreneurship is all about recognizing the social problems and achieving a social change by employing entrepreneurial skills, principles, processes and operations. It is all about clearly identifying a particular social problem, following it up by organizing, creating and managing a social venture to achieve the desired result. The change may or may not include a thorough elimination of a social problem. It is undisputedly hard work - harder than economic profitmaking entrepreneurship. Improving the existing circumstances to an acceptable level may ask for a lifetime of unrelenting dedication.

The main difference between an economic entrepreneur and a social entrepreneur is: the profit-seeking entrepreneurs measure their performance by profit, revenues and rise in stock prices. Social entrepreneurs, on the other hand, may not have profit intent altogether, or they may amalgamate profit goals with the intent of a positive give-back to society. Thus, they focus on accomplishing social, cultural, and environmental betterment, through poverty alleviation, health care and community development activities, which overlap with the operational domains of voluntary organizations. Nevertheless, social entrepreneurs are as ambitious, persistent and determined in achieving their vision of social change, and as off-beat, innovative and risk-taking in formulating their

The need for and significance of social entrepreneurs is fraught with a multiplicity of justifications. Just as business entrepreneurs change the face of business, social entrepreneurs act as the change agents for society, seizing opportunities others miss and improving systems, inventing new approaches, and creating solutions to change society for the better. While a business entrepreneur might create entirely new industries, a social entrepreneur comes up with new solutions to social problems and then implements them on a large scale for the benefit of the humanity.

What distinguishes the function of social entrepreneurship from the voluntary sector and charityoriented activities that the social entrepreneurs do not seek or scout for donors and sponsors to fund their activities, unlike the voluntary and charity organizations? They utilize and rely on self-generated income, rather than income from donations and grants. They are motivated by a clear vision of what the society should look like when their goal is accomplished, and work towards making it come true. They are not happy with the status quo; they crave to bring about what they believe is a healthy change.

In an endeavour to promote social entrepreneurship, the MSME-DI, Hyderabad organized a meeting with transgenders on livelihood through entrepreneurial development, on 20th July 2019 at its premises. This will be eventually followed by a special Skill Development Programme to impart technical skills to transgenders, followed by credit facilitation through financial institutions.

# **CLUSTER ACTIVITIES**






Rs.44,00,000 per transport vehicle. Shri. D. Chandrasekhar, AIA, MSME-DI, Hyderabad; Shri. P.




